- 1942 May Started as Mitsuishi Kogyo Co., Ltd., processing castings of various kinds and repairing machine tools.
- 1946 Nov. Began manufacturing and selling various kinds of stainless steel (welding-based) products.
- 1947 Apr. Changed company name to Sakura Seisakusyo.
- 1948 Oct. Moved head office to Higashi-yodogawa-ku, Osaka City.
- 1951 Aug. Changed company name to HISAKA WORKS, LTD.
- 1953 Dec. Developed plate heat exchanger.
- 1954 Feb. Opened new Horiage Factory (former Yodogawa Factory).
- 1958 Jul. Developed ball valve.
- 1959 Mar. Opened Tokyo Office in Chuo-ku, Tokyo (now Tokyo Branch).
- 1962 Mar. Opened new Konoike Factory (now Konoike Plant).
- 1965 Jan. Moved head office to Higashi-konoike-cho, Higashi-osaka City.
- 1969 Nov. Introduced large sized press machine to Konoike factory.

- 1987 Sep. Stocks designated on First Sections of Tokyo, Osaka and Nagoya Stock Exchanges.
- 1998 Sep. Certified with quality management system (ISO 9001).

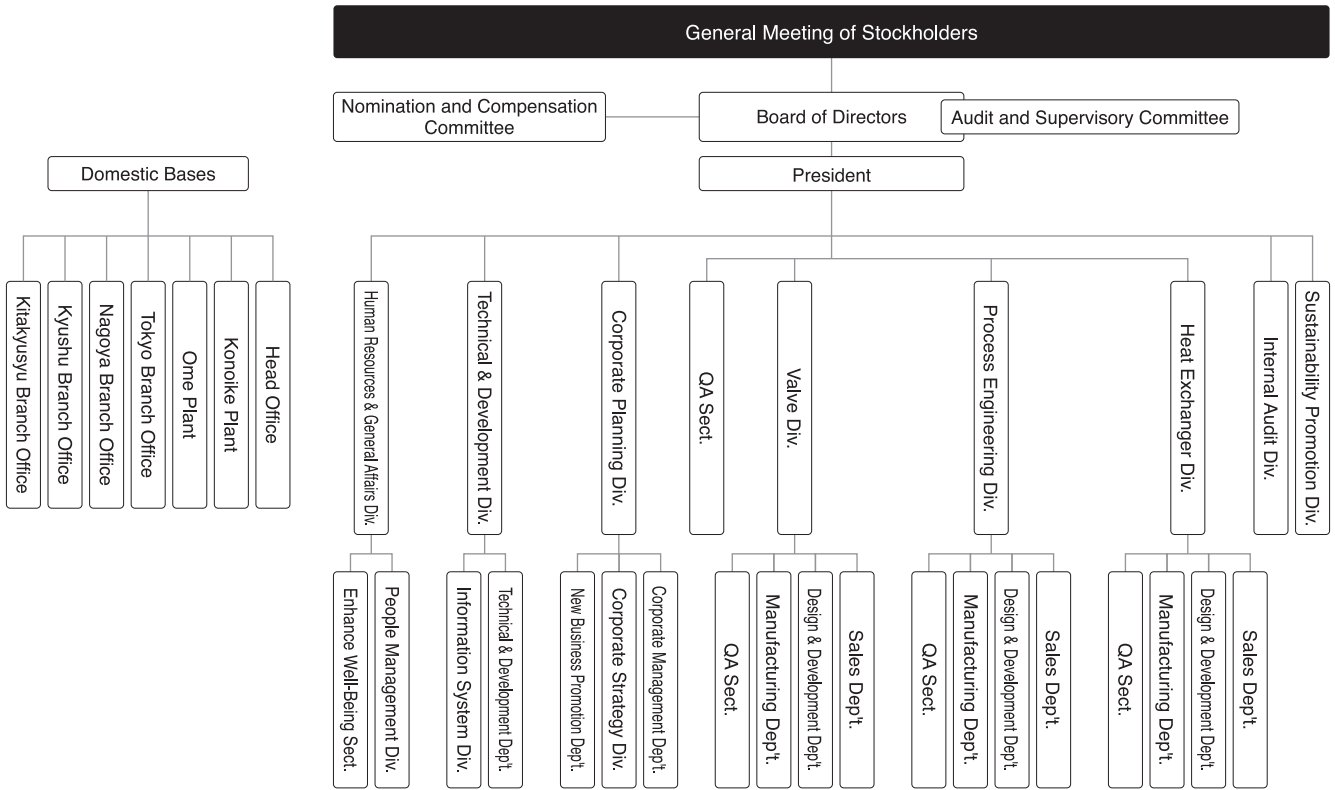

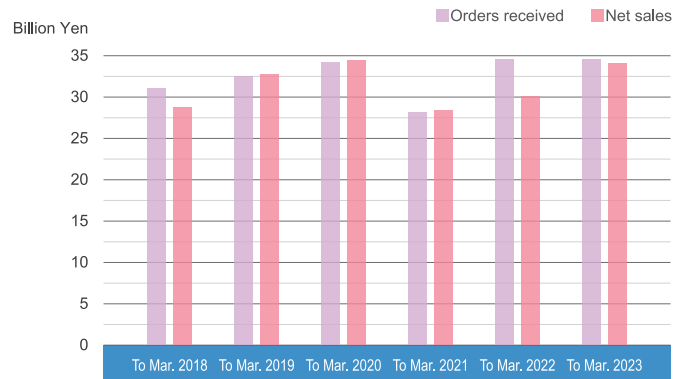

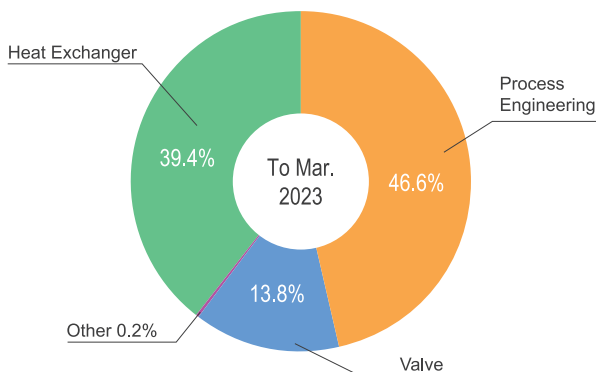
